I am directed to convey sanction for provisional affiliation of School for Secondary School

The above sanction is subject to fulfilment of the following conditions :—

1. The School will follow syllabi and courehs as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.
2. The school shall appiont only qualified and eligible staff.
3. The School will help the Board in the smooth conduct of the examination by placing the necessary accommodation i.e. Halls, Rooms available at the school premises and furniture at its disposal for holding its examinations free of charge, if required to do so.
4. The school will spare sufficient teachers for invigilation purpose at the examinations of the Board as may be required by the Board.
5. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required to do so.
6. The school will provide Laboratories, Library and other facilities as per norms of the Board.
7. The school will abide by the condition of affiliation already prescribed or may be prescribed by the Board from time to time.
8. Annual fees @ -Rs. 500/- per annum for the year 94-95, 95-96, 96-97 be also remitted at an early date
9. Code No allotted to your school is 21701. This may please be noted and quoted for any correspondence with the Board. Original Receipt No. 129A/1 dt. 22.9.95 for Rs. 5000/- is also sent here with for office record.

10. The school will not sponsor candidates for Board's examination of any other school/Branch which is not affiliated to the Board.
  11. The school will create Reserve Fund as per the requirement of the Affiliation Bye-Laws/ rules of the Directorate of Education Delhi in the joint names.
  12. If within the above period the school Authority fails to satisfy the condition of the Affiliation by-laws, the provisional affiliation granted to it will automatically stand terminated.
